#### Bible Study Questions on the Books of Joshua and Ruth

Introduction:

This workbook was designed for Bible class study, family study, or personal study. The class book is suitable for teens and up. The questions contain minimal human commentary, but instead urge students to study to understand Scripture.

Enough questions are included for teachers to assign as many questions as they want for each study session. Studies may proceed at whatever speed and depth will best accomplish the needs of the students.

Questions labeled "think" are intended to encourage students to apply what they have learned. When questions refer to a map, students should consult maps in a Bible dictionary or similar reference work or in the back of their Bibles. (Note: My abbreviation "b/c/v" means "book, chapter, and verse.")

For class instruction, I urge teachers to assign the questions as homework so students come to class prepared. Then let class time consist of **discussion** that focuses on the Scriptures themselves. Let the teacher use other Scriptures, questions, applications, and comments to promote productive discussion, not just reading the questions to see whether they were answered "correctly." Please, do **not** let the class period consist primarily of the following: "Joe, will you answer number 1?" "Sue, what about number 2?" Etc.

I also urge students to emphasize the *Bible* teaching. Please, do not become bogged down over "What did the author mean by question #5?" My meaning is relatively unimportant. The issue is what the Bible says. Concentrate on the meaning and applications of Scripture. If a question helps promote Bible understanding, stay with it. If it becomes unproductive, move on.

The questions are not intended just to help students understand the Scriptures. They are also designed to help students learn good principles of Bible study. Good Bible study requires defining the meaning of keywords, studying parallel passages, explaining the meaning of the text clearly, making applications, and defending the truth as well as exposing religious error. I have included questions to encourage students to practice all these study principles.

Finally, I encourage plain applications of the principles studied. God's word is written so souls may please God and have eternal life. Please study it with the respect and devotion it deserves! For whatever good this material achieves, to God be the glory.

- 5. What request did his daughter make of Caleb 15:18,19?
- 6. What city did Judah not capture at this time −15:63?
- 7. Describe the southern border of Ephraim 16:5-9.
- 8. What error did they commit regarding the Canaanites 16:10?
- 9. What women inherited in Manasseh 17:3,4? Explain why and give b/c/v.
- 10. Describe the territory given to half the tribe of Manasseh west of Jordan 17:7-11.
- 11. What complaint was raised by some descendants of Joseph 17:14-16?
- 12. How did Joshua respond to them 17:17,18?

  - 5. Who received the second lot? Where was their inheritance? Why -19:1-9?
  - 6. Who received the third lot -19:10-16? See a map and name the surrounding tribes.
  - 7. Who received the fourth lot -19:17-23? What tribes and borders surrounded them?
  - 8. Who received the fifth lot -19:24-31? Describe the borders and tribes around it.
  - 9. The sixth lot went to whom -19:32-39? Describe its location.
  - 10. Who received the last lot -19:40-48? Where was it? What did they later add?

- 5. What choice or challenge did Joshua put before the people in 24:14,15? What choice had Joshua himself made?
- 6. *Application:* What can we learn here about man's free will power of choice? Give other *passages* confirming man has this power.
- 7. **Application:** What can we learn here about parents' duty in leading their families? Give other **passages** confirming this duty.
  - 8. What choice did the people profess to make 24:16-18? Why?
  - 9. How did Joshua emphasize the seriousness of their commitment 24:19-25?

10. Where the Joshua write a record of this – 24.20? What is the significance of this?
11. Describe what else Joshua did to give a future reminder of their commitment – 24:26,27. Where else have similar reminders been mentioned?

- 6. **Special Assignment:** What did the old law say about intermarriage with people of the nations surrounding Israel (**passages**)? How do you explain the marriage of Naomi's two sons to women of Moab?
- 7. What happened to Naomi's sons? What did she decide to do then? Who went with her 1:5-7?
  - 8. What did Naomi suggest her daughters-in-law do 1:8-10? How did they respond?
  - 9. What explanation did Naomi give why they should not go with her 1:11-13?
- 10. **Special Assignment:** Explain the significance of Naomi's answer. What is the significance of her statement that she has no sons to become their husbands? Explain the Old Testament principle to which this refers. Give Scripture.

  - 4. What advice did Boaz give Ruth in her work 2:8,9?

  - 6. What reasons did Boaz give to Ruth for his treatment of her?

- 6. What blessing did the people and the elders pronounce on Boaz and Ruth 4:11,12? Explain the references to other Old Testament women.
  - 7. What blessing did God give Boaz and Ruth in their marriage 4:13?
  - 8. What blessing did the women hope the child would be for Naomi 4:14,15?
- 9. What name did the women give to the child, and what role did Naomi serve for him 4:16,17?
- 10. **Special Assignment:** What role did Obed play in Biblical genealogy? Why is this important to us?
